Terms:

This agreement will become effective on date of signature of both Parties. It shall remain valid for a period of 3 years from the date of last signature, with the understanding that it may be modified by written mutual content of both parties. This agreement may be terminated by either Party with advanced written notice of at least 30 days. Upon notice of termination both Sterling Institute of Management Studies & Midshipmite Recruiters Pvt Ltd agree to work in good faith, to enable visiting scholars to complete their respective Programs / Training unhindered by the termination. The agreement may be extended with the mutual consent of both the Parties after the 3year period, and it must be renewed in writing.


