Upon notice of termination both Sterling Institute of Management Studies & _______ agree to work in good faith, to enable visiting scholars to complete their respective Programs / Training unhindered by the termination. The agreement may be extended with the mutual consent of both the Parties after the 3 year period, and it must be renewed in writing.
